- They proceed to operate a canceled bank account for K2012001293 - Zebtec PTY LTD.
- Debt, contracts, withdrawals are not present.
- They disrupt cash flow by not issuing banking cards or transfers.
- They retain our trust funds mentioned for municipal tax.
- They not adhere to several instructions.

=> Our companies cannot operate.

b) Moorestephens Tax advisor and Trustee

Mr. Stephanus Bernardus Truter (ID 6510085081083)

- He proceeds doing business with my trust and companies, not ordered and declined.
- He did not payed compiling annual reports for 2018.
- We suspended further cooperation in a written manner.
- He not adheres to the POPI Act and distributes information's.
- He not ensures his responsibilities are not capable.
- He not payed municipal taxes/services for us
- He not released our trust funds so that I can proceed.

=> Our companies cannot operate.

c) Some officials or Government related

Western Cape Government, Redtape

Police Station, George

High Court Masters, Cape Town

SARS and eFiling, George

- I offered SARS support to bring eFiling back into operation regarding our tax numbers.

4. Payed but not provided annual report	R 13,800.00
5. Outstanding rent	R 54,000.00
